A tax rate of \$ 0.10 per \$100 valuation has been proposed by the governing body of **Fort Bend County Emergency Services District No. 2.**

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for **Fort Bend County Emergency Services District No. 2** from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that **Fort Bend County Emergency Services District No. 2** may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that **Fort Bend County Emergency Services District No. 2** is proposing to increase property taxes for the 2020 tax year.

Property Tax Rates in Fort Bend County ESD 2

This notice concerns the 2020 property tax rates for Fort Bend County ESD 2. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year's voter-approval tax rate: \$0.100429/100
