Notice of Public Hearing on Tax Increase

A tax rate of \$ 0.10 per \$100 valuation has been proposed by the governing body of **Fort Bend County Emergency Services District No. 5**.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for **Fort Bend County Emergency Services District No. 5** from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that **Fort Bend County Emergency Services District No. 5** may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for **Fort Bend County Emergency Services District No. 5** exceeds the voter-approval rate for **Fort Bend County Emergency Services District No. 5**.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for **Fort Bend County Emergency Services District No. 5**, the rate that will raise \$500,000, and the current debt rate for **Fort Bend County Emergency Services District No. 5**.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that **Fort Bend County Emergency Services District No. 5** is proposing to increase property taxes for the 2020 tax year.

A **PUBLIC HEARING** ON THE PROPOSED TAX RATE WILL BE HELD ON August 24, 2020 at 6:30 p.m, at Northeast Fort Bend Fire Station No. 2, 11000 Clodine Road, Richmond, Texas 77407.

Fort Bend County Emergency Services District No. 5 may take action on the proposed tax rate on August 24, 2020 at 6:30 p.m., following the hearing to be held.

PLEASE BE ADVISED THAT THE HEARING AND ADOPTION MEETING MAY BE CONDUCTED VIA CONFERENCE CALL DUE TO COVID 19 MEETING RESTRICTIONS. PLEASE REVIEW THE MEETING NOTICE POSTED ON THE DISTRICT'S WEBSITE 72 HOURS BEFORE THE HEARING TO DETERMINE IF THE HEARING AND ADOPTION MEETING WILL BE HELD IN PERSON OR VIA CONFERENCE CALL.

The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate. However, the proposed tax rate exceeds the rate that allows voters to petition for an election under Section 26.075, Tax Code. If **Fort Bend County Emergency Services District No. 5** adopts the proposed tax rate, the qualified voters of the **Fort Bend County**

Emergency Services District No. 5 may petition the Fort Bend County Emergency Services District No. 5 to require an election to be held to determine whether to reduce the proposed tax rate. If a majority of the voters reject the proposed tax rate, the tax rate of the Fort Bend County Emergency Services District No. 5 will be the voter-approval tax rate of the Fort Bend County Emergency Services District No. 5.

Property Tax Rates in Fort Bend County ESD No. 5

This notice concerns the 2020 property tax rates for Fort Bend County ESD No. 5. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year's no-new-revenue tax rate: \$0.093503/\$100

This year's voter-approval tax rate: \$0.096864/\$100
